Briefing 8 am, first dog to start immediately after

Parking will be along the right side of the driveway as you come up. Leave space between the car in front of you, for them to be able to open their trunks. **BE CAREFUL NOT TO PARK TOO CLOSE TO THE EDGE OF THE DRIVEWAY.**

In light of **Covid precautions**, there will be no indoor crating in the main building; please plan to work from your vehicles. Please maintain social distancing. Masks will be at the discretion of the judge and the individual exhibitor. There will be a limited number of teams in the building at a time. **Running order and Blind assignments will be emailed prior to the event.** Be sure to include your email on your entry form.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs, will be run at the end of their class/trial, and must wear “panties” while competing. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge’s briefing.

Ribbons will be awarded to all qualifying teams – Rosettes will be awarded for all placements and new titles.
